**Mr Khalid Abdullah al-Ali** (**Qatar**, 2<sup>nd</sup> **term ended 31/12/2013**), is an Associate Professor of Human Genetics in the Department of Biological Science and Director of the Foundation Programme of Qatar University. He is a Member of the Arab Ethics Committee for Science and Technology.

**Mr Rajaona Andriamananjara (Madagascar, 2<sup>nd</sup> term ends 31/12/2015)**, President of COMEST, is an economist. He is the President of the Madagascar Academy of Science, Arts and Letters and also President of the newly founded Madagascar Committee of Ethics of Science and Technology.
